## **PBCCD Reporting**



- Previously FHEIs reported emissions to SFC via EAUC
- Climate Change (Scotland) Act 2009 included Public Sector Major Players to Report on carbon emissions – Public Bodies Climate Change Duties (PBCCD)
- Sustainable Scotland Network manage process
- November 2014 Reporting process started
- November 2015 Reports due for trial year (online)
- November 2016 Deadline for first mandatory year
- Now Reports and analysis published
- 2 sections required & recommended

#### Universities & Colleges Climate Commitment for Scotland

#### We recognise the challenge:

- We recognise the scale and speed of climate change, and the likely effect on Scotland's people and places, impacting adversely on our economy, society and environment
- We consider that early action to address the expected changes will create long-term economic, health, social and
- We acknowledge the Scottish Government objective to reduce emissions by 80% by 2050 to avert the worst impacts of climate change; and realise we have a role to play in this.


