Programme Background

National Transport Strategy

Where does the eBike Grant Fund fit in?

Grant funding to support:

- Establishment or expansion of public ebike hire/loan/trial schemes
- Establishment or expansion of employee ebike pool schemes
- Development of exemplar facilities/logistics/operations projects

2018/19 Projects

- Funded 497 ebikes and ecargo bikes
- 46 projects
- Over £925,000 funding offered

Recipients included Community Development Trusts, Local Authorities, NHS Boards, 8 FHE bodies, and community groups.

energy Re-DISCOVER Dundee saving trust

Projects ranged from small, village based loan and hire schemes, to public, app-based hire schemes, rural focused transport solutions, to urban-centred logistics and facilities projects.





eBike Grant Fund – 2019/20

- £1,140,000 total funding pot, covering:
 - Grants via applications
 - Pilot projects with Active Travel Delivery Partners
 - Home Energy Scotland eBike Trials

Category A	Category B
Grants up to £25k	Grants up to £200k
Open to public sector organisations and constituted community groups	Open to public sector organisations and constituted community groups
25% match funding required for community groups, in-kind funding considered	50% cash match funding required for all interested parties
50% cash match funding required for public sector bodies	Focussed on large scale workplace pool ebike schemes and publicly available hire schemes.
Community led trials/hire schemes or workplace pool ebike schemes	





What is eligible?

- Pedelec ebikes and ecargo bikes: definition of pedelec from hmrc <u>https://www.gov.uk/electric-bike-rules</u>
- Safety, cargo and security equipment: helmets, hi-vis, lights, panniers, child seats, locks. Basic repair equipment will also be considered
- Non-ebike/ecargo bikes will be considered if the project is engaging with groups considered 'vulnerable': disabled, elderly, families with young children
- Subsidised access to large, public hire schemes (category B only)

What isn't eligible?

- Storage equipment, bike stands etc. Applicants are being directed to Cycling Scotland programmes (Cycle Friendly Communities/Employer/Campus) for this
- Training
- Maintenance equipment (other than basic puncture repair, pumps)

Key dates, areas of focus for 2019/20

13th May - Programme opens for applications

- 28th June Closing date for Category A Fund
- 5th August Closing date for Category B Fund
- 20th September Closing date for Category A Fund*
- 2nd December Closing date for Category B Fund*

In 2019/20 Transport Scotland and Energy Saving Trust are particularly keen to see submissions for projects that will address key Programme for Government 2018/19 areas of interest:

- Providing low-carbon alternatives to car use
- Inclusive access to services, targeting job-seekers, students, young families
- Developing cycle-friendly businesses and destinations

- 3. For Category B projects, expression of interest noted via form on website emailed to <u>eBikeGrantsScot@est.org.uk</u>
- 4. Applications available as of 13th May
- 5. 1-to-1 support, webinars or teleconferences offered in support where necessary
- 6. Feedback on eligibility and applications provided before assessment panel consisting of EST, Transport Scotland, Cycling Scotland*
- 7. Further rounds announced if funding remains
- 8. Funds to be spent by end March 2020.
